What information do we collect?

When you visit www.lsa-cp.com, we automatically gather and store the following information in order to track the use of our website:

- the IP address from which the website is accessed
- the name of the domain from which our visitors access the Internet
- the type of browser and operating system used to access the website
- the date and time of your visit to www.lsa-cp.com
- the pages, files, documents and links accessed during your visit
- the internet address of the website from which you linked to www.lsa-cp.com (i.e. the previous site you visited, which referred you to www.lsa-cp.com)

What happens to the information collected?

Control Risks will not make any attempt to identify individual website users or their particular browsing activities. The information listed above is stored and used in the aggregate only, in order to provide us with information about the general use of www.lsa-cp.com. Our website log files are analysed in order to make improvements to www.lsa-cp.com: for example, if we find that some pages are rarely visited, we can improve them.

What are cookies?

Cookies are small pieces of information sent to your browser by a website that you visit. Cookies can be either persistent or session based.

Persistent cookies: they are stored on your computer and contain an expiry date, and may be used to track your browsing behavior upon return to the issuing web site. When you register on a website, cookies allow the website to remember your information so you will not have to re-enter it the next time you visit. You can set your browser to refuse cookies from any website you visit. If you choose to do that you can usually still gain access to most, if not all of the site, but you may not be able to conduct certain types of transactions (such as shopping) or take advantage of some of the interactive elements offered.

Session cookies: these cookies are short-lived. They are used only during a browsing session, and expire when you quit your browser. Upon closing your browser the session cookie set by the web site is destroyed and no personal information is maintained which might identify you should you visit the web site at a later date.
